Meeting Proceedings:

- 1.3 Authorize payment of the disbursements for the month of September was presented by Secretary/Treasurer Sandra Armenta. Motion to approve by Jorge Morales and seconded by Gustavo Camacho. Motion was approved unanimously.

Reports:

President's Report- Lou La Monte

President La Monte reported on the current standing of the Liability Trust Fund Oversight Committee elections. Jose Pulido, Cudahy will serve as the Central division delegate, with Steve Mandoki, Lawndale as the alternate. Ken Striplin, Santa Clarita will serve as the North division delegate and Paul Arevalo, West Hollywood as the alternate. Reva Feldman, Malibu will serve as the at large alternate. Council seat elections are currently being accepted and will be reported at the next Executive Board meeting.

President La Monte updated the Executive Board on Sam Olivito's retirement dinner and the need for sponsorships to help cover the cost of the event. After much

discussion, the Executive Board opted to purchase two round trip tickets to Italy for Sam Olivito, rather than a sponsorship.

Legislative Committee- Chair Jorge Morales

Chair Morales introduced Susan Trigueros-Sifuentes and Frank Gomez of the Southern California Gas Company and spoke briefly regarding the reason for their presentation.

Special Presentation: So Cal Gas Company

Two member of the Southern California Gas Company gave a presentation in which they were seeking CCCA's support in reopening their Aliso Canyon facility. They explained in great detail, the amount of stringent requirements the facility underwent to ensure compliance with SB 380.

James Bozajian moved that Frank Zerunyan draft a letter of support on behalf of the Executive Board pertaining to supporting the reopening of the Aliso Canyon under the conditions that all the SB 380 obligations are met. Gustavo Camacho seconded. Motion was approved unanimously.

Special Events Committee- Chair James Bozajian

Chair Bozajian gave a brief recap report of the Fall Educational Summit that was held on Catalina Island. He reported that while the number was not substantial, CCCA did make a small profit.

Unresolved Business:

City Manager Chair Reva Feldman reported that CCCA is currently awaiting an invitation for travel from the Cuban Embassy. There are several options for the basis of the invitation, which include: business, cultural and educational. Updates will be reported as they come in.
