#### **Meeting Proceedings**

- The meeting Minutes of May 2019 were presented by Secretary/Treasurer Lindsey Horvath. Motion to approve minutes was made by Jeff Wood and seconded by Liz Reilly. No abstentions. Motion was approved unanimously.
- The Treasurer's Report for the month of May 2019 was presented by Secretary/Treasurer Lindsey Horvath. The following questions were presented:
  - Secretary/Treasurer Lindsey Horvath asked for a list of all open bank accounts with balances. Executive Director Marcel Rodarte agreed to provide to her.
  - Secretary/Treasurer Lindsey Horvath inquired about the amount of bank accounts that were open and if they were necessary. Executive Director Marcel Rodarte explained that they are all used for different purposes including gaining interest for money not regularly used.
  - Nancy Tragarz asked why there such a high balance in the checking account that was
    not being used and not gaining interest. She asked if this money could be moved to a
    different type of account in order to make money off interest. Executive Director
    Marcel Rodarte inquired with Commercial Bank of California representative, Alyssa
    Rizo, and confirmed that the money could be put into a money market account to

- withdraw as needed yet make money off interest. He will follow up with Alyssa to work on this option.
- Secretary/Treasurer Lindsey Horvath asked why the final numbers for AMS as well as SLOT were not accurate. Executive Director Marcel Rodarte explained that there is a new accountant working on the financials, and she is aware and working on finalizing those numbers.
- Secretary/Treasurer Lindsey Horvath asked why there was no budget line for the City Managers Summit. E.D. Marcel explained that this summit as well as Local Advocacy Day were not included as they were new projects, but will be on our budget going forward, as we will continue to work on having them.
- Secretary/Treasurer Lindsey Horvath asked why there were different lines for Travel Budget. E.D. Marcel Rodarte explained that he categorized travel expenses by, local, legislative, and conference, in order to have an accurate account of each expense.
- Secretary/Treasurer Lindsey Horvath asked if the budget is reallocated based on actuals or if left as is. E.D. Marcel Rodarte confirmed that the budget is adjusted annually by actuals.
- Secretary/Treasurer Lindsey Horvath asked who approved monthly expenses and what is provided for approval. E.D. Marcel Rodarte explained that the expenses are approved by the entire Executive Board and individual receipts are attached to each expense for justification.
- Nancy Tragarz asked for clarification on Coffee Cups expense for AMS. E.D. Marcel Rodarte explained those were sleeves that were purchased with CCCA logo for attendees to use over their coffee cups at the conference.

Motion was made by Liz Reilly and seconded by Mark Waronek to approve the Treasurer's Report. No Abstentions. Motion was approved unanimously.

Secretary/Treasurer Lindsey Horvath asked for some time during the meeting to review
each item on the disbursements list and to add up each of the totals. A recess was called by
President Sandra Armenta at 8:58AM. Meeting was called back to order by President
Sandra Armenta at 12:52PM. Authorize payment of the disbursements for the month of
June was presented by Secretary/Treasurer Lindsey Horvath. Motion to approve was made
by Gustavo Camacho and seconded by Jeff Wood. No Abstentions. Motion was approved
unanimously.
