Reports

President's Report- President Sandra Armenta

• President Armenta welcomed all those in attendance and introduced Michael Davit, Councilmember for La Cañada Flintridge, to give a welcome to his City.

- President Armenta also spoke about future events and encouraged those present to participate in as many as possible.
- President Armenta welcomed Alyssa Rizo and Kevin Gonzalez from Commercial Bank of California and asked them to present on the different Money Market or savings accounts that would be available to the association.

Executive Director's Report

- Executive Director Marcel Rodarte gave an update as to why the financial reports had not been reflecting properly. He explained that the chart of accounts needed to be rebuilt and redirected. He has worked on making the accounts more concise. He explained that all the money received has still been going in the general fund, but now is being accurately reported.
- Executive Director Rodarte also mentioned that in error we have been paying a fee of \$22 a month to Commercial Bank of California. They found the error and the association will be refunded those fees by the end of the week.
- Executive Director Marcel Rodarte mentioned he is still working with Tripepi Smith on finalizing the report for the Strategic Planning Session.
- Executive Director Rodarte asked the board about their preference of our slogan being "Strengthen Local Control" or "Strengthen Local Governance." This will be added on next month's agenda for a vote.
- Executive Director Rodarte mentioned that due to an event planning license that he has, he can receive a refund from the hotels we stay at during our conferences. He mentioned there are a few different ways to obtain this refund, and how the funds can be distributed. He will send all the details of this to the legal committee and will be discussed again at next months meeting.
- Executive Director Rodarte asked the Executive Board members if they would like
 to nominate a recipient for Legislator of the Year award for the Fall Educational
 Summit, it was discussed that they would prefer that award be presented during
 AMS.
